

## DO I HAVE TO PAY ALL OF MY INFRINGEMENT AT ONCE?

If you are paying your infringement directly to the Shire of Capel when first issued, or at Final Demand stage, then payment must be made in full, part payments are not accepted under any circumstances.

Once lodged with Fines Enforcement Registry you are able to make an application to them for a payment arrangement. You will need to contact them directly to organise this.

# PENALTY!



Infringement notices may be issued by any of the Shire of Capel's Authorised Officers for any breach or violation of our Local Laws, and State Laws.

### **I'VE BEEN ISSUED AN INFRINGEMENT, WHAT ARE MY OPTIONS?**

- Pay the penalty amount in full to the Shire of Capel, either in person (cash, eftpos) or over the phone (credit card) before the due date.
- Write in to contest the infringement, providing as much detail as possible for the reason you believe it should not apply. These can either be posted to the Shire (PO Box 369, Capel WA 6271) or submitted via email to **info@capel.wa.gov.au** and must include your infringement number.
- If you ignore the infringement and take no action, a Final Demand notice will be issued to you, with additional fees added.

- At the Final Demand stage, you can either pay in full (inclusive of any fees), or elect to have the matter heard in court.
- Should you continue to ignore your infringement past this stage, it will be lodged with the Fines Enforcement Registry.

### **MY INFRINGEMENT HAS BEEN LODGED WITH THE FINES ENFORCEMENT REGISTRY—WHAT DOES THIS MEAN?**

The Fines Enforcement Registry is part of the Court and Tribunal Services division of the Department of the Attorney General. The Fines Enforcement Registry enforces outstanding fines from numerous prosecuting authorities and all of Western Australia's courts. Matters are referred to the Fines Enforcement Registry where further sanctions may be imposed on fine defaulters to collect fines.



### **WHAT WILL HAPPEN IF I CONTINUE TO IGNORE MY INFRINGEMENT?**

If you continue to ignore your infringement notice once it has been lodged with the Fines Enforcement Registry (FER) you run the risk of further penalties being imposed on you by the FER including:

- Additional Costs
- Suspension of your Driver's Licence
- Suspension of your Vehicle Licence
- Immobilisation of your vehicle
- Seizure and sale of your property
- Publication of your name on the FER's fine defaulters website (public).

In addition to the above, if you elect to have the matter heard in court and the court imposes fines on top of the original infringement, these can also be lodged with the FER if left unpaid. In addition to the penalties listed above that can be imposed by FER, the following may also apply for unpaid court fines:

- An order to undertake community service
- Imprisonment
